2. City of Montague, Dowling Street, Sheridan Street to Old Channel Trail, \$205,482 STP, \$51,370.60 local match, \$35,650.00 Other, \$292,503 total
3. City of Whitehall, Main Street, Mears Ave west to Lake Street, \$217,000 STP, \$93,000 local match, \$310,000 total.
4. Muskegon County Road Commission, Fruitvale Road, US-31 to Walsh Road, \$290,000 STP, \$73,000 local match, \$363,000 total.

5. Muskegon County Road Commission, Russell Road, \$272,000 STP, \$100,000 local match, \$125,000 local match, \$497,000 total.
6. City of Montague, Hancock Street, Sheridan Street to Old Channel Trail, \$205,482 STP, \$51,370.60 local match, \$35,650.00 Other, \$292,503 total
