IV. FY 2020-2023 Projects – Committee members distributed forms with details of all proposed 2020-2023 projects. After discussion a prioritized list was agreed upon as follows:

1. City of Whitehall, Mears Ave – Benston to White Lake Drive, \$375,000 STP, \$275,000 local match, \$650,000 total.
2. Muskegon County Road Commission, Whitbeck - Eilers to Old Channel Trail, \$375,000 STP, \$175,000 local match, \$325,000 TEDF F, \$875,000 total
3. City of Montague, Stanton/Dowling – Water to Cook/Cook to Whitbeck, \$375,000 STP, \$145,910 local match, , \$520,910 total
4. Muskegon County Road Commission, South Shore Drive – White Lake Drive to Nestrom Rd, \$375,000 STP, \$145,000 local match, \$200,000 TAP, \$720,000 total.
5. City of Whitehall, Lake Street - Country Club to White Lake Drive, \$375,000 STP, \$100,000 local match, \$135,000 local match, \$510,000 total.

6. Village of Lakewood Club, Kenwood Drive - \$375,000 STP, \$93,750 local match, \$468,750 total

A motion was made to approve the proposed prioritized list. Motion carried. **m/s Beishuizen/ Armstrong**
