XVIII. FY2026 – 2029 PROJECT AMENDMENT

Mason County:

FY 2026 – Job Number 223615 and Job Number 214591 are being changed from FY 2027 to FY 2026. JN 223615 is a HMA Wedging project with Chip and Fog Seal on Custer Road from Fountain Road to Freesoil Road. JN 214591 is an HMA Wedging project with Chip and Fog Seal on Custer Road from the north limit of the Village of Custer to Fountain Road.

A motion was made and supported to approve amendments to the FY2026-2029 project list. Motion approved. ***M/S Lamb/Keson***

XIX. UPDATE FROM MDOT

Mr. Brian Stark provided multiple updates to the task force:

- Finalized TEDF budget numbers will be sent out in December, and if there is a project that members want obligated prior to December then members will have to communicate with Mr. Stark regarding this and can receive 90% of the final amount.
- An additional 3-4 projects were able to be completed in FY 2025 due to bid savings.
- August redistribution contributed to statewide bridge inspections – the remaining amount will go into FY 2026 budgets.
- There will be an RTF 101 training held virtually in February of 2026 as well as another round of statewide RTF training in the fall of 2026.
- The Fed Aid buyout will not be occurring in FY 2026; the decision whether the Fed Aid buyout program will happen in FY 2027 has not been made

yet.

- The RTF bylaws have been amended to allow the RTF to use STL funds on non-construction projects.
- New allocation targets will not reflect the changes to the census until FY 2027. Fremont is now a Small Urban area.

- Mr. Joel Fitzpatrick clarified to the task force that if there are any small non-construction projects that members would like to see done, submit them as illustrative projects to be considered. A list of eligible projects will be sent out.
