IV. TRANSPORTATION IMPROVEMENT PROGRAM –

Mr. Brian Mulnix reviewed the proposed FY2017-2020 TIP Amendment J that was approved and recommended to the Policy Committee for approval by the WestPlan Technical Committee at their February 1, 2018 meeting. Motion approved. m/s Hughes/Klohs

FY2017-2020 TIP Amendment J

- **FY2018, Add Project,** Harbor Transit (5307)— Bus replacement (4) small buses- Federal \$512,000 State \$128,000 Total \$640,000
- FY 2018, Cost Increase, MATS, Federal funding (5339) \$40,000, State Cost \$10,000, Total Cost \$50,000.
- **FY2020, Add Project,** Muskegon County Road Commission (Rural Task Force) Ellis Road- Ravenna Rd to Moorland Road, \$438,090 STL, \$239,582 State D, Total \$677,672.
- **FY2018, Add Project,** Muskegon County Road Commission (Rural Task Force) River Road-Buys to Peterson, \$438,090 STL, \$109,523 County, Total \$547,613.
- **FY2018, Add Project**, Muskegon County Road Commission (Local Bridge) MCRC is consolidating several bridge preventive maintenance projects in order to have them bid under one contract. These bridge projects have all been previously selected for funding by the regional bridge committee.
 - o Whitehall Road at Bear Creek, SN7645: \$54,400 federal, \$10,200 state, \$3,400 local. Total \$68,000
 - o Witham Road at Bear Creek, SN7644: \$58,400 federal, \$10,950 state, \$3,700 local. Total \$73,000
 - o Memorial Drive at Green Creek, SN7648: \$92,000 federal, \$17,250 state, \$5,750 local. Total \$115,000
 - Scenic Drive at Duck Lake outlet, SN7674: \$38,400 federal, \$7,245 state, \$2,415 local. Total \$48,300
 - o Fruitvale Road at White River, SN7653: \$74,000 federal, \$13,875 state, \$4,625 local. Total \$92,500

Note from MDOT: These projects were programmed with federal bridge, state, and local funds. However, because we have run out of On-System federal funds, I will have to convert them to state and local funds only.

New funding figures are: \$376,960 in State and \$19,840 Local, Total \$396,800

- **FY2018, Add Project**, Muskegon County Road Commission (Local Bridge) MCRC is consolidating several bridge preventive maintenance projects in order to have them bid under one contract. These bridge projects have all been previously selected for funding by the regional bridge committee.
 - o Orshal Road at Duck Creek, SN7675: \$16,000 federal, \$3,000 state, \$1,000 local. Total \$20,000
 - Blackmer Road at Crockery Creek, SN7691: \$121,600 federal, \$22,800 state, \$7600 local. Total \$152,000
