I. CALL TO ORDER

Chairperson Matt Farrar called the meeting to order at 1:31. Attendance was taken via roll call. A quorum was present.

II. APPROVAL OF PREVIOUS MINUTES

Minutes from the previous meeting were reviewed. A motion was made and supported to approve minutes as presented of the May 7, 2020 Technical Committee meeting. Motion approved. *M/S Jeske/Murphy*

III. PUBLIC COMMENT

The WestPlan Public Participation Plan procedure was followed to achieve public participation for this meeting. There were no comments from the public.

IV. HIP FUNDING - Mr. Brian Mulnix presented the projects which were proposed to use the available HIP funding. Two projects were considered for funding.

- Project #: **205362**- City of Muskegon Heights- Hackley from Park to Fifth, Add HIP funding to federal portion making project an 80/20 split- Total cost \$324,000 Federal \$259,200 Local \$ 64,800
- Project #: **205349**- City of Montague- Hancock from Sheridan to Old Channel Trail- Add HIP funding to federal share, increase total project cost from \$329,315 to \$404,000. Total cost \$404,000 Federal \$319,176 Local \$ 84,824

A Grand Haven was proposed to use the remainder of the HIP funding. After discussion, it was agreed that this third project would come back to the committee in September. A motion was made and seconded to approve the projects, and to include them in Amendment 9. Motion approved. *M/S Bolt/ Murphy*.

II. FY2020-FY2023 TIP – Amendment 9: Mr. Mulnix presented Amendment 9 for the FY 2020-2023 TIP, Mr. Tyler Kent reviewed the MDOT projects.

2021

- Project #: **127479**- MDOT- M-104 from Kruger to 148th- ADD ROW Phase- \$8,000
- Project #: **200664**- MDOT- M-104 from Spring Lake Channel east to Lake Ave. – GPA Cost Change- Total Cost \$747,000 State Cost \$135,581

2022

- Project #: **127478**- MDOT- US-31 @ Pierce, Winans, 158th Ave. Indirect Left Turns- Moving project from 2020 to 2022- Total Cost \$865,000 State \$156,997

A motion was made and seconded to approve the amendment, including the previously approved HIP projects. Motion approved. *M/S Laughlin/Beishuizen*

V. 2045 LONG RANGE TRANSPORTATION PLAN –Mr. Brian Mulnix stated was no update at this time.

VI. US-31 CORRIDOR STUDY- (GRAND HAVEN) MDOT – Mr. Tyler Kent gave a PowerPoint presentation on the proposed Corridor Study. Discussion ensued.

VII. MPO ROUNDTABLE

- Mr. Jay Bolt gave an update on the Village of Fruitport's 3rd Avenue project for FY2020.
- Ms. Amy Haack gave an update on air quality issues.
- Mr. Luke Walters gave an update on the UWP.

Mr. Mulnix;

A little over a year ago, I read in the Muskegon Chronicle that the area of M-120 and US-31 (and River Road) was one of Muskegon County's hot spots for accidents. I have personally seen many accidents in that area. We have lived on East River Road since 1965 and have seen the addition of hundreds of new homes and more being built daily and the traffic is scary.

One would think that the west bound traffic on East River Road would safely enter M-120 traffic via Old Orchard Lane at the traffic signal but, that is not always the case. I am not a traffic engineer but, I do have a couple of ideas. If you are not familiar with this area, take some time and park your car near there most any time of the day and count the close calls.

Please Consider:

#1) Blocking west bound traffic from River Road onto M-120. Traffic would still be open to: the bank, the gas station, the beauty shop and Rigler Road but, blocked from turning west onto M-120. This would direct west bound traffic to use Old Orchard Lane with the safety of a traffic signal.

#2) East bound traffic from M-120 onto River Road would remain the same. Remove the "stop" sign at Old Orchard Lane and make east bound traffic on River Road a thru lane. The left turn from East River onto Old Orchard Lane would remain the same as a stop. East bound traffic from Old Orchard Lane would become a "stop".

FY2020-2023 WestPlan TIP Amendment (10)

- 201924 CON phase: I-96 freeway signing upgrade, various locations in WestPlan and GVMC MPOs, and Rural areas
 - Current programmed cost: \$865,000.00
 - Proposed cost: \$1,310,000.00
 - Increase Request: \$445,000.00

- 127479 CON phase: M-104 between Krueger and 148th Ave
 - Current programmed cost: \$560,000.00
 - Proposed cost: \$826,000.00
 - Increase Request: \$266,000.00

- 205371- City of Muskegon- Change limits of project from Peck- Apple to Strong- To: Peck from Apple to Merrill- funding amounts remains as programmed.

- 205364 Grand Haven- Fulton Avenue- Add additional HIP Funding to the federal portion of this project- Approximately \$14,000 added to the current programmed amount of \$482,772- This item was tabled in August, will need MPO Committee approval to move forward.
