III. APPROVAL OF AGENDA

VI. **HOST (Oceana County)**

Commissioner McGlothin welcomed all to the Zoom meeting on July 20, 2020.

CHAIRPERSON'S REPORT VII.

Commissioner McGlothin has nothing to report today.

VIII. **EXECUTIVE DIRECTOR'S REPORT**

Staff is still productive working from home. Gale Nobes is in the office three days a week; Syndi Copeland, two days a week.

Transportation – WMSRDC received word that the MDOT Service Development and New Technology (SDNT) grant application was approved in the amount of \$150,000. The grant was submitted on behalf of the Muskegon Area Transit System (MATS) and Harbor Transit to conduct a West Michigan Regional Transit Systems Governance and Organization Transition Study. Once we receive the official Project Authorization, WMSRDC will hire a consultant to conduct the study, looking at the structure of each organization, how to increase productivity, and potential merger of the two systems.

WMSRDC Transportation staff has been discussing a potential update to the Transportation Public Involvement Plan and how the agency can be more inclusive in our efforts to engage the minority and underserved communities.

Economic Development – WMSRDC staff continue to work with communities within all five counties regarding potential EDA projects under the EDA CARES Act Disaster Relief Program funding. As part of the Federal CARES Act passed in late March, EDA was allocated \$1.5 billion to distribute through their regional partners. The Chicago Regional Office received \$225 million to distribute within their six-state region.

WMSRDC, along with Grand Valley State University, submitted an application for a grant to conduct a Market Analysis to better serve lakeshore entrepreneurs. The application was submitted for funding under the Disaster Relief Program dollars. If the \$87,000 grant is awarded, WMSRDC will be the fiduciary on behalf of GVSU.

WMSRDC also submitted a grant application for \$400,000 as part of the EDA CARES Act non-competitive Economic Development District grants. Tasks identified as part of the grant include the development of an Economic Development Disaster Resiliency and Recovery Plan, technical assistance including broadband facilitation and coordination, and organizational capacity support for coronavirus response. This is a 100% grant with no required matching funds. Grant awards are expected to be announced soon, and all expenses will be able to be backdated to July 1, 2020.

We hope to create a Regional Revolving Loan Fund for small business, gap financials or entrepreneurial startups. We had a CEDS committee meeting on Friday to discuss the next steps. Currently we are doing due diligence to complement existing RLFs and not duplicate. We would love to have any board members involved in this process. Fundraising will be necessary to raise the local match requirement. Please email Erin if you are interested.

Environmental – all of our construction projects have started up again. We have been funded for Little Cedar Creek, and we have been asked to continue looking into other projects for Great Lakes Restoration Initiative funding opportunities. We did submit an application for Little Flower Creek which was not successful.

Local Government Services -

The Michigan Infrastructure Council's Asset Management Self-Assessment Tool was delayed due to COVID. As a result of the delay, transportation program staff has agreed to help Stephen and Jamie begin this process, utilizing virtual platforms.

Other Activities –

Erin talked about the COVID-19 Response Plan for WMSRDC. It appears there will not be able to be in-person meetings any time soon. Everyone received our newsletter which revealed our new logo. WMSRDC will begin changing office supplies using the new logo.

IX. FINANCIAL STATEMENTS

Amanda reviewed all financials and reported that going into our final quarter our cash Motion was made by Commissioner Nesbary and supported by remains strong. Commissioner Gustufson to approve the June 2020 financials. Motion carried.

There was a guestion regarding MERS. At this point WMSRDC is overfunded but looking into the future we could be underfunded in some of the scenarios they have put forth. Erin and Amanda are discussing strategies moving forward on how to maintain the 100% funded level.

X. NEW BUSINESS - There was no new business.

XI. ROUND TABLE

- Ken Johnson stated that although COVID has brought some setbacks, construction downtown is still moving forward. It also appears that paid parking at Pere Marguette Beach is doing what it was intended to do.
- Andrea Large mentioned the Community Foundation is hosting a match day to help our nonprofits with some expenses (email Andrea to get information)
- Dale Nesbary stated that the West Michigan Food Cooperative building will be up and running in about four months. Agribusiness industry in West Michigan will receive much help. August 24 college start is still on - all online classes and on campus classes.
- Burt Cooper is interested in the Broadband service, especially as there are no funds to provide this service to his community.
