Not every county has finalized their projects for the COVID funding which is ok. We do not need to approve them all at this meeting. The most important project timing wise is the Ludington Mass Transit project.

COVID FUNDING PROJECT AMENDMENTS RTF 14

APRIL 2021

LAKE COUNTY

- COVID HIP funding, 56th Street, Lake County Road Commission, \$167, 681.
- COVID HIP funding, Floor repair, Yates Dial A Ride, \$9,500.

MASON COUNTY

- COVID HIP funding, Employee bonus \$18,000, Ludington Mass Transit.
- Remainder to funding to be utilized by Mason County Road Commission, project to be determined.

NEWAYGO COUNTY

- No projects selected at this time.

MUSKEGON COUNTY

- COVID HIP funding, add funding to existing FY2022 Harrisburg Road project.

OCEANA COUNTY

- COVID HIP funding, \$50,000 in sealcoating projects in cooperation with various cities and villages, specific projects to be determined.
- Remaining funding to be utilized by Oceana County Road Commission, project to be determined.
