VI. CHAIRPERSON'S REPORT

VII. EXECUTIVE DIRECTOR'S REPORT

Transportation -

West Michigan Regional Transit Systems Governance and Organization Transition Study proposals were due this last Friday. WMSRDC received three, and a meeting is scheduled this Friday to review and score the proposals.

The FY21 Pre-Unified Work Program (UWP) meeting was held on February 19 and included WMSRDC staff, the Michigan Department of Transportation, and the Federal Highway Administration. WMSRDC was reviewed on the management of our program, and staff was commended for their exceptional work during the pandemic. The budget for FY22 was identified. The UWP is due to MDOT in June with approval from MDOT expected in July or August.

Economic Development –

The Newaygo County Regional Educational Service Agency (NCRESA) and the City of Muskegon EDA grant applications were not successful. A meeting was held with EDA, WMSRDC, and NCRESA to identify opportunities to strengthen their application. EDA encouraged both to resubmit.

In the American Recover Plan stimulus package signed on March 11, EDA will receive \$3 billion nationally. WMSRDC will work with eligible applicants within our region to identify potential projects. Questions should be directed to Erin.

Staff continues to be involved in local, regional, and state-wide broadband discussions. Anyone interested in joining the broadband group should reach out to Erin.

Environmental -

WMSRDC staff continues working on year 2 funding through our NOAA Regional Partnership grant. We hope to hear back on Little Cedar Creek construction, White River, and Stony Creek projects. Staff continues working on Little Cedar Creek engineering and design.

Staff submitted three new environmental grant applications: One to EGLE for tree planting and environmental education in the Ryerson Creek watershed, one to Sustain our Great Lakes (SOGL) in partnership with the United Way for work in Ryerson Creek near their building, and one to EGLE to develop a Watershed Management Plan for Little Flower Creek.

Other -

The Michigan infrastructure Council is developing an Asset Management Champion Program for Michigan. The free training will be available to 100 individuals from across the state and will run from April through June. There are approximately eight people signed up from our region.

Bob Kittle from Munetrix will be holding a meeting for municipal finance managers on April 21. Please recommend that the financial folks in your jurisdictions participate. All 120 jurisdictions have access to this program through WMSRDC for free.
