Job # 214665 – Traffic Safety (High Friction Surface Treatment), Limits: Lincoln St, curve west of Leon St, Federal: \$55,280, Local: \$13,820, Total: \$69,100, **New Phase added to TIP**

City of Muskegon

Job # 205376 – Reconstruct – City of Muskegon, Limits: Terrace St from Shoreline Dr to Apple Ave, Federal: \$631,593 → \$853,497, Local: \$467,000 → \$743,289, Total: \$1,098,593 → \$1,596,786, **Cost Increase > 25%**
