RESOLUTION APPROVING THE WESTPLAN 2050 METROPOLITAN TRANSPORTATION PLAN

WHEREAS, the West Michigan Metropolitan Transportation Planning Program (WestPlan) is the designated Metropolitan Planning Organization (MPO) for the Muskegon/Northern Ottawa area; and

WHEREAS, the development of a Metropolitan Transportation Plan is a requirement of both the Federal Transit Administration and the Federal Highway Administration; and

WHEREAS, the WestPlan 2050 Metropolitan Transportation Plan has been developed pursuant to USC 23 Section 134 as amended by the Infrastructure and Investment Jobs Act (IIJA); and

WHEREAS, it is necessary to document compliance with the IIJA; and

WHEREAS, the WestPlan 2050 Metropolitan Transportation Plan identifies transportation facilities that should function as an integrated metropolitan transportation system; and

WHEREAS, the WestPlan 2050 Metropolitan Transportation Plan was developed in a manner that considered the planning factors referenced in Section 134 as amended by the IIJA; and

WHEREAS, the WestPlan 2050 Metropolitan Transportation Plan includes a financial analysis that demonstrates how the projects that have been identified will be funded and indicates the resources that are reasonably expected to be made available to carry out the Plan; and

WHEREAS, the WestPlan 2050 Metropolitan Transportation Plan includes investment strategies and other measures necessary to ensure the preservation of the existing transportation system and includes projects that will enhance the efficiency of the existing transportation system to relieve vehicular congestion and improve the mobility of people and goods; and

WHEREAS, the WestPlan 2050 Metropolitan Transportation Plan was developed through a process that included input from private citizens, affected public agencies, private providers of transportation and other interested parties; and


WHEREAS, the WestPlan 2050 Metropolitan Transportation Plan was analyzed and has been shown to conform with the State Implementation Plan for air quality; and

April 17, 2024

WHEREAS, the United States Environmental Protection Agency designated part of Muskegon County, as a Nonattainment Area for the 2015 ozone national ambient air quality standards (NAAQS) in Aug 2018; and

WHEREAS, the United States Environmental Protection Agency designated all of Muskegon County, as a maintenance area in May 2007 for the 1997 ozone NAAQS; and

WHEREAS, per the court decision in South Coast II, beginning February 16, 2019, transportation conformity determinations for the 1997 ozone NAAQS will be needed for those areas that were maintenance areas when the 1997 ozone NAAQS was revoked and then attainment for the 2008 ozone NAAQS; and

WHEREAS, the 2015 Nonattainment Area does not extend to cover the whole county's 1997 maintenance area the remaining 1997 ozone maintenance area is contained in the partial county maintenance area and

WHEREAS, the West Michigan Metropolitan Transportation Planning Program (WESTPLAN) is the designated Policy Committee and Metropolitan Planning Organization for the urban area in Muskegon County MI; and

WHEREAS, the conformity of the WESTPLAN 2050 Metropolitan Transportation Plan and 2020-2023 Transportation Improvement Program (TIP) in Muskegon County will be pending support I by the Federal Highway Administration after local action on the Transportation Conformity Determination Report for the 1997 Ozone NAAQS Partial Muskegon County Maintenance Area by the WESTPLAN Policy Committee; and

NOW THEREFORE BE IT RESOLVED, that the Policy Committee of WESTPLAN supports the conclusions of the 1997 ozone conformity report for the Muskegon Partial County Orphan Maintenance Area for the WESTPLAN 2050 Metropolitan Transportation Plan and 2020-2023 Transportation Improvement Program; and

WHEREAS, the United States Environmental Protection Agency designated part of Muskegon County, as a Nonattainment Area for the 2015 ozone national ambient air quality standards (NAAQS) in Aug 2018; and

WHEREAS, the West Michigan Metropolitan Transportation Planning Program (WESTPLAN) is the designated Policy Committee and Metropolitan Planning Organization for the urban area in Muskegon County MI; and

WHEREAS, the conformity of the WESTPLAN 2050 Metropolitan Transportation Plan and 2020-2023 Transportation Improvement Program (TIP) in Muskegon County will be pending support by the Federal Highway Administration after local action on the conformity analysis document by the WESTPLAN Policy Committee; and

WHEREAS, the WESTPLAN 2050 Metropolitan Transportation Plan and 2020-2023 Transportation Improvement Program (TIP) in Muskegon County were analyzed in accordance with 40 CFR 51 for air quality conformity and the results of the conformity analysis conducted by the Michigan Department of Transportation demonstrates that the forecasted volatile organic compound (VOC) and nitrogen oxide (NOx) emissions for all analysis years are below the State Implementation Plan (SIP) budgets;

NOW THEREFORE BE IT RESOLVED, that the Policy Committee of WESTPLAN support the results of the 2015 ozone conformity analysis for the Muskegon Partial County Nonattainment Area for the WESTPLAN 2050 Metropolitan Transportation Plan and 2020-2023 Transportation Improvement Program; and

BE IT FURTHER RESOLVED, that the 2015 Ozone Conformity Analysis for the Muskegon Partial County Nonattainment Area demonstrates conformity with the SIP for air quality as required by provisions of Title 40 CFR 51.390 and 93, and Title 23 CFR 450.

WHEREAS, per the court decision in South Coast II, beginning February 16, 2019, transportation conformity determinations for the 1997 ozone national ambient air quality standard (NAAQS) will be needed for those areas that were maintenance areas when the 1997 ozone NAAQS was revoked and then attainment for the 2008 and 2015 NAAQSs, referred as "orphan" areas; and

WHEREAS, in November 2018 the United States Environmental Protection Agency (EPA) promulgated guidance to assist in implementing the court decision in South Coast II, providing the requirements to demonstrate transportation conformity for areas that were "orphan" areas; and;

WHEREAS, the EPA designated the Grand Rapids nonattainment area of Kent and Ottawa counties as a maintenance area for the 1997 ozone NAAQS in May 2007 and attainment in July 2012 for the stricter 2008 ozone NAAQS and in August 2018 for the 2015 ozone NAAQS; and

WHEREAS, the Grand Rapids limited maintenance area is deemed an "orphan" area, and the WestPlan is partially contained in the Grand Rapids limited orphan maintenance area; and

WHEREAS, the WestPlan is the designated Policy Committee and Metropolitan Planning Organization for the Muskegon/Northern Ottawa urban area; and

WHEREAS, the conformity of the WestPlan's 2050 MTP including the 2020-2023 Transportation Improvement Program (TIP) in Ottawa County will be pending support by the Federal Highway Administration after local action on the conformity report by the WestPlan Policy Committee; and

NOW THEREFORE BE IT RESOLVED that the Policy Committee of the WestPlan supports the conclusions of the Transportation Conformity Determination Report for the 1997 Ozone NAAQS for the Grand Rapids limited orphan maintenance area for the WestPlan 2050 MTP and 2020-2023 Transportation Improvement Program in Ottawa County; and

- Model: New partial interchange at I-96 & Sternberg Road. Westbound off / eastbound on, 2035.
- Model: 2,500 additional vehicle ADT from the area east of Harvey Street, south of Sternberg Road, north of Pontaluna Road, west of I-96, 2028.
- Model: M-46 west of US-31 and Shoreline Drive
- Model: Shoreline Drive roadway reconfigurations on US-31 BR/Shoreline Drive

Illustrative Projects

US-31 Business Route over White River (Whitehall and Montague):

- Bridge replacement due to deteriorating condition. Increase bridge span and height to accommodate floodplain requirements. May include roadway improvements. Pending further study.

MDOT-Grand Region Illustrative Projects / Unfunded Needs for WestPlan 2050 L RTP

This following list was provided by MDOT Grand Region staff and provides illustrative / unfunded MDOT projects and studies that address corridors or areas that have been discussed at several WestPlan Technical Advisory and Policy Committee meetings.

MDOT-Grand Region Illustrative Projects / Unfunded Needs:

1. US-31 (Beacon Boulevard) in Grand Haven and Grand Haven Township:
 - Continue monitoring operations along the corridor and identify intersection improvements, where needed.
 - Pursue funding for recommended improvements from the study that were discussed and agreed upon by MDOT and the City of Grand Haven.
2. US-31 from I-96 to M-46:
 - Continue monitoring travel characteristics and operations on this section of freeway; evaluate feasibility of weave/merge lanes and ramp modifications at and between major freeway interchanges.
3. US-31 @ Sherman Boulevard (local road but may include improvements US-31):
 - Identify improvements for existing operational conditions; continue to explore future interchange modification and improvement options.
4. I-96 @ US-31:
 - Continue to evaluate operational improvements and ramp modifications; Interstate (I-96) Access changes may be required.
5. LRBOI Casino Development/Proposed:
 - Review and monitor state and local transportation impacts from the proposed casino and other related developments around the area; identify improvement needs and options.
6. M-231 Corridor:
 - Continued analysis, with possible study, of local and MDOT improvement needs and options in and around the corridor, in coordination with the Macatawa Area Coordinating Council (MACC).
 - Continue expansion of ITS applications and infrastructure in the MPO area
