### **III. APPROVAL OF THE PREVIOUS MINUTES**

The minutes were reviewed from the October 16, 2024, meeting. A motion was made and supported to approve the minutes of the September 18, 2024, meeting. Motion approved.

### **IV. PUBLIC COMMENT (AGENDA ITEMS)**

The WestPlan Public Participation Plan procedure was followed to achieve public participation for this meeting. No members of the public spoke.

### **V. TRANSPORTATION IMPROVEMENT PROGRAM**

**A. FY2023-2026 TIP AMENDMENT 20** – Mr. Joel Fitzpatrick presented on the FY2023-2026 TIP Amendment 20. The amendment was presented to the Technical Committee and was recommended for approval by Policy committee members. Mr. Fitzpatrick elaborated on each item line stating that the first two lines are one job split due to different funding sources, the third line is a transit job funding change, and the remainder are MDOT bridge preventative maintenance jobs. Mr. Tyler Kent informed the committee that a 5-year plan for bridge preventative maintenance has been approved for the M-231 bridge, and the amendments regarding the bridge are a request for an overall GPA increase. A motion was made and supported to approve the FY2023-2026 TIP Amendment 20. Motion carried. *M/S Salter/Hires*

**B. FY2026-2029 TIP DEVELOPMENT** – Mr. Joel Fitzpatrick informed the committee that every road agency, minus Spring Lake, submitted projects for FY2026. A work session to discuss funding will be held the morning of December 5, 2024 prior to the Technical Committee meeting. Details will be ironed out during the Technical Committee meeting of December 4, 2024, and will be brought to the January meeting for voting.

### **VI. 2050 METROPOLITAN TRANSPORTATION PLAN (MTP)**

Mr. Joel Fitzpatrick informed the committee that the 2050 MTP has previously been approved, but there are no present updates. The monitoring of the plan will resume. Monitoring of the Harbor Transit facility project will continue.

### **VII. NEW BUSINESS/MPO ROUNDTABLE**

Mr. Joel Fitzpatrick announced that the asset management council has made funding available for culvert inventory data collection and inspection. He also informed the group that WMSRDC is hiring consultants to work on a non-motorized plan. After receiving positive results from an RFP sent out at the beginning of October, a meeting with these consultants will take place in Early December. The goal of this non-motorized plan is to encourage and gain reconnection of communities that have been previously cut off due to road infrastructure.

## **A. PUBLIC TRANSPORTATION**

- a. Mr. Bob Lukens reported on MATS transit numbers. MATS fixed routes passenger numbers were up while GO2 numbers were down. This decline is likely due to a driver shortage, but they are estimated to increase with the season change. Mr. Lukens also announced to the committee that Muskegon Airport with Denver Air Connection has begun service as of November 1, 2024. A steady climb in passengers has been noted, as well as the significant increase in airport usage compared to prior months. There are currently renovations and repairs being made to the terminal, and they are hoping to bring a restaurant to the airport within a year.

## **B. MDOT UPDATES**

- a. Mr. Kent reported that the I-96 construction has wrapped up and there will be signal modernization on M-46 east of US-31. He confirmed that MDOT wants to collaborate with WMSRDC on TIP development.
- b. Discussion ensued regarding environmental concerns during the upcoming winter season regarding salting roads. Mr. Kent ensured that there is a research group looking into alternatives, like beet juice and sand.

## **VIII. PUBLIC COMMENT**

The WestPlan Public Participation Plan procedure was followed to achieve public participation for this meeting. No members of the public spoke.

## **IX. ADJOURNMENT** – The meeting adjourned at 2:06 p.m.
