• President's budget excluded EDA, but House and Senate subcommittees included it. This is "par for the course" and generally good news for EDA funding prospects.

- W. MI Ag Cluster Impact Analysis
- Due by September 30, 2025
  - o Team: WMSRDC, Highland Economics, MSU Product Center, MSU RS&GIS
- August 27 AM at WMSRDC reserved for project presentation and work session
- USDA Rural Development application submitted to support implementation and establish a committee

#### 3) Natural Resources & Quality of Life and the CEDS

- Attendees reviewed and discussed the Goal and Objectives outlined in the CEDS.
  - Natural Resources comments & suggestions:
    - Support industries that are based on natural resources
    - Emphasize sustainability of outdoor activities
  - Quality of Life suggestions:
    - The topic of "Smart Growth" is rather dated and might be replaced with "Transect" language.
    - Child care reiterated as a significant issue
    - Consider mention of marketing quality of life
    - Use of "non-motorized" might be replaced with "multi-modal" to encompass both recreational and practical uses.
